The Northwest Oklahoma Alliance held its quarterly networking luncheon on February 22, 2022 in Woodward Oklahoma at the Woodward Conference Center. The meeting focused on funding opportunities for Northwest Oklahoma through grants and financial programs to help cities and towns improve both job opportunities and economic development for the rural areas of Northwest Oklahoma.

The guest speakers were Jessica Jantzen (Economic Development Coordinator), Jennifer Firgard (Community Development Specialist), and Vicki Eggers (Economic Development Director) from the Northern Oklahoma Development Authority and the Oklahoma Economic Development Authority. The Northwest Oklahoma Alliance is dedicated to coordinating, developing, and promoting regional resources.






Jennifer spoke on the REAP program that allows communities to improve general economic conditions in rural Oklahoma through three funding sources for water, sewer, street, bridges, and other miscellaneous economic development projects. She also went over the CDBG program, CDBG application opened as of February 2022 and Jennifer will be traveling to various communities to promote and assist with these applications and funding opportunities.

Vicki discussed the funding opportunities offered by the federal government. The Paul Brauhn Historic Revitalization Subgrant Program, requires that the communities be certified as local government which can take up to six months to become qualified as such, but is a great opportunity to preserve historic buildings in communities. She also spoke about the funding through the Jobs Act and the Infrastructure Investment Bill that will authorize funds to build transportation, address climate change, support energy infrastructure, and supply broadband internet in the communities.







Jessica presented information about the Rural Housing Initiative that seeks to help revitalize and grow Oklahoma's rural communities by making funds available for citizens who wish to build a new home. This program is set up for rural communities with less than 20,000 residents and applicants that make less than \$91,900 for a 4 member household and less than \$121,300 for 5+ member households. These funds can be used to acquire new permanent residences, essential household equipment, and miscellaneous site preparation costs.




EDA Grant Provides Funding for New Industrial

Park Infrastructure

On June 15, the Economic Development Administration (EDA) announced the Garfield County Industrial Park as a recipient of an EDA Grant for \$800,000 for infrastructure improvements. The EDA grant will be matched with \$225,394 in local funds and is expected to create 30 jobs. The \$800,000 award is one of the largest economic development grants awarded in our area, said Don Roberts, chairman of the GCIA board of directors.

NODA assisted with the application and administration of the grant. Lisa Powell, executive director of Enid Regional Development Alliance, said "It was truly a team effort."

With assistance from NODA, Garfield County Industrial Authority (GCIA) received an Economic Development Administration (EDA) grant to install water, sewer, and road infrastructure in the Garfield County Industrial Park, located on North 54th Street in Enid. The \$800,000 federal grant, with matching funds from GCIA and the City of Enid, totaled over \$1,087,000 plus the City's staff time and expertise with the design, engineering, and inspection work.

City and economic development officials were present as the newest road at Garfield Industrial Park, Venture Road, was officially opened March 2 with a ribbon-cutting ceremony, and creates space for at least six new businesses in the remaining 65 acres of the industrial park.

The grant funds will be used to construct a new road to Enterprise Drive along with constructing water and wastewater infrastructure. The industrial park is managed by the Garfield County Industrial Authority and is located on Enterprise Drive & 54th Street. There are four businesses currently in the park, including Tyson Foods, Nextlink Internet, Winfield United, and Cogent.

The Revolving Loan Fund (RLF) Program was designed to provide funds to businesses that cannot get traditional bank financing. These funds allow these businesses to grow which leads to additional employment opportunities in the region. NODA staff assists qualified applicants, reviews, and helps process these applications for the RLF Committee and NODA board reviews. The RLF Committee gathers in person and via Zoom to review a loan application that had been submitted.




